EXECUTIVE ORDER OF THE GOVERNOR

TASKFORCE ON HEALTHCARE SYSTEMS IN MOMBASA COUNTY

The County Government of Mombasa has in place 44 hospitals serving the general public with the Coast General Hospital as the County level five medical facility supported by four attendant level four hospitals under the management of the Board of Directors of the Coast General Hospital.

Mombasa County is Kenya's second largest city county in terms of population facing a threat arising from an increasingly urbanized populace with a rising need for efficient and effective healthcare service delivery.

Having found both prudent and necessary to establish a framework to review and improve upon Mombasa County's healthcare systems;

THEREFORE, IN EXERCISE of the powers conferred by Section 30 of the County Governments Act, the realization of Article 43 (1) (a), part two of the fourth Schedule of the Constitution and all other enabling laws, I, ABDULLSWAMAD SHARIFF NASSIR, the Governor of the County Government of Mombasa, do hereby ORDER and DIRECT:

- THAT, THE TASKFORCE ON HEALTHCARE SYSTEMS IN MOMBASA is hereby established.
- II. THAT, any other executive efforts into similar lines of enquiry are hereby subsumed into the Taskforce on Healthcare Systems in Mombasa and stand dissolved.
- III. THAT, THE TASKFORCE ON HEALTHCARE SYSTEMS IN MOMBASA, shall be constituted as follows.

TERMS OF REFERENCE FOR THE TASKFORCE

- Engage stakeholders including but not limited to the general public, healthcare workers, the National Hospital Insurance Fund among others towards:
 - Reviewing the architecture of healthcare delivery including human resources for health and ICT for health in the county of Mombasa;
 - Assessing on the state of physical healthcare infrastructure including buildings and heavy & movable equipment in the county of Mombasa;
 - iii. Auditing the state of financing for healthcare in the county of Mombasa;
 - iv. Evaluating the state of supply chains for healthcare in the county of Mombasa;
 - Recommending the upgrading and/or special purposing of existing medical facilities;
 - vi. Audit public healthcare related human resource currently employed by the County Government and make recommendations on addressing the skills gap;
 - Assessing and recommending on the implementation of a comprehensive Health Management Information System for all County Government Hospitals;
 - viii. Assessing and recommending strategies on addressing disease patterns; and
 - Formulating lasting solutions towards achieving universal healthcare that is affordable and accessible in the county of Mombasa.
- Conduct any other matter ancillary to or in furtherance of any of the foregoing Terms of Reference; and
- The Taskforce may co-opt any other persons as may be required to assist it in the discharge of its functions.

The Taskforce shall prepare and submit its report to the Governor of Mombasa County together with its recommendations within thirty (30) days from the date of its appointment
